

OFFICIAL CONTEST RULES

Online voting will continue through 2/13/13. Only one vote per email address will be accepted. The winning couple will be chosen by Facebook public and will be announced on 2/14/13. Winner will be contacted via phone and email from the Embassy Suites Denver Downtown Catering staff. Once the winner is contacted online posts will follow.
